An action log to be created for the following:

- Photographs of the areas concerned to be emailed to the Clerk
- The noticeboard in the village centre is to be cleared on a regular basis
- The hedge adjacent to the workshop will eventually be removed and a new planting scheme put in place. A log to be recovered from the hedge and moved to Meadow Park.
- Gotham Road Car Park. Grounds maintenance around the area of the recycling centre
- Grass in front of the Chinese Restaurant on the Rest Garden side to be included in the cutting schedule.
- Grass at the bottom of Castle Hill strimming
- Land behind the new noticeboard needs attention (Rushcliffe Borough Council) and possibly consider some form of landscaping.
- Remove old noticeboard behind the wall.
- Edges to the area on the banks of Sheepwash Brook to be strimmed and tidied
- Nettles/weeds to be removed from under benches and included in the grass cutting regime.
- The Glebe Grounds Maintenance
- Post Office Grounds Maintenance

### 16/AME/008 TO REVIEW PROGRESS AND CONSIDER APPROVAL FOR ONGOING PROJECTS IN RELATION TO:

**Parking** – The Health Centre Car Park Project is complete. Yellow No Parking lines are to be added to stop parking around the edge of the car park on the exit road. The Breast Screening Unit is located in the car park for the next few weeks.

**Meadow Park** – A bench and handrails on Heron Bridge have been removed/vandalised and used in the creation of a den. The Police are involved. Minutes from the Friends of Meadow Park for March and May are available.

Rest Garden – The fencing is now installed. Planting under the direction of Cllr Conrad Oatey

**Workshop Extension** – Cllr Jeff Jones is in the process of submitting documents to Rushcliffe Borough Council

Closed Churchyard – Nothing to report

**Play Equipment** – Report from the Clerk tabled. Canopy – Pictures/drawings of potential canopy replacements were studied and discussed. The three options tabled were considered and on balance it was agreed to go with option 1 for the time being. However to leave the existing post in place for now and await any feedback from users. Agreed.

Burial Ground – The new gate between the Burial Ground and the Allotments has been installed.

**CCTV** – The CCTV is up and running and the pictures it transmits are very good. The Police are happy with it and have been trained to use it. Anti-vandalism paint is to be applied to the camera pole.

**Oldershaw Trust Land** – Cllr Kevin Shaw is to liaise with the Playground Inspector regarding the resiting of the remaining swings on the old play area to the Oldershaw Trust Land. The idea of a Community Orchard is to be visited via the newsletter for responses.

**Public Toilets (Rota) & Disabled Toilet** – The Councillors who agreed to rota the opening and closing of the toilets on a Sunday and Bank Holidays will agree between themselves on their availability and each will be given their own set of keys. The disabled toilet to be accessed via the Radar Keys.

**Community Boost Project – Trim Trail (subject to funding) –** Our project for a Trim Trail is to be supported by Interserve. A meeting of all Councillors with an interest in the project together with Interserve/Groundwork Nottingham is to be arranged before the end of May.

**Sheep Plank Lane** – A report from the Rights of Way Officer was tabled. Clearly there were lots of questions which remain unanswered at this time. Councillors are asked to visit the area and in the meantime the Rights of Way Officer will be invited to the next Amenities meeting – Agreed
