# 15/108 TO APPROVE THE BUDGET, THE EARMARKED RESERVES AND SET THE PRECEPT FOR 2016/2017

The Chairman referred members to the budget proposals tabled and reported that the primary reason for an increase in the Parish Council part of the council tax was that expenditure was gradually increasing and would eventually exceed our income in view of the number of projects which had been and needed to be undertaken. Our reserves had been applied in previous years to enable the Council to maintain little increase in the council tax. This was no longer the case and in order to deliver the planned projects the Council needed to increase its council tax by approximately £11.00 per annum.

#### **RESOLUTION**

That the budget tabled be adopted with an increase of £11.58 per annum based on a Band D property tax band.
