## 1. Gotham Road Car Park Extension plus other parking issues -

We are still awaiting information from CADENT regarding possible Gas Main under pavement on Gotham Road, so exit ramp cannot yet be constructed. North Midland (Contractor) continue to chase Other works are on schedule for completion this week including tarmacadam surface as far as the location of the ramp. Jeff Jones as architect is keeping in close daily contact

Concerns were raised about parking in the village, including on pavements and verges. It was agreed to request Andy Brown CC to ask for the Camera Car to film in the village and take enforcement action

#### 2. Play Equipment

- A) Skate Park we have now received images of the revised plans, but no start nor completion date, despite chasing by the Clerk
- B) Replacement items received from Proludic Grounds staff to install
- C) Repair to roundabout Streetwise greased bearings, so much improved now
- D) It's been reported that the Rubber Mulch playground surface is marking children's clothing and shoes, and making skin dirty. The Clerk would contact Abacus, supplier, to see if common elsewhere and due to hot weather

#### 3. Trim Trail, Meadow Park -

Clarification for rejection awaited from Nottinghamshire CC WP meets 18.7.18

4. **Christmas Lights 2018 Planning** – new electrician attended and brief report received – quotation requested

Councillor Marie Males requested consideration be given to the area in front of the Pinfold if any new lights are planned

5. **Public Water Fountain** – some information received and one plumber quoted for installation. Clerk to investigate options and costs and report back

## 6. East Leake Playing Fields

- Pitch refurbishment to be planned for 2019
- Boundary hedge to be reinstated
- Pavilion plans not progressed as quickly as hoped
- Our plans for land opposite to include overflow car park to be developed

7. **Litter bins** – successful meeting with RBC, contract understood It was agreed to make suggestions for replacement bins and locations once their new "Dual Stream" designs have begun to appear. We may need to undertake a formal survey rather than a piecemeal approach

#### 8. Appearance of the Village -

- Report on signs received from Councillor Liz Taylor, many of which it was agreed to report to County Council Highways (VIA) for consideration
- The Tidy Team have again been active and are concentrating on the Tour of Britain cycle route down Main Street to Costock Road
- Councillor Marie Males to ask Paul Phillips at Rushcliffe Borough Council about Streetwise tidying the Sheep Wash Brook near Manor Farm Meadow
