#### 18/PC/047 CHAIR'S ANNOUNCEMENTS

- The house opposite the Greengrocers on Main Street, known as Home Farm, is for sale, and has "Pre-planning" advice available with suggestion of up to 3 dwellings on site, despite contravening the East Leake Parish Council Neighbourhood Plan V1 on need for Village Centre non-residential development. This matter has been taken up with RBC
- Residents on West Leake Road are hearing rumours that the whole field beyond Field End Close might be subject to a planning application with access from Woodgate Road near the Railway Bridge
- We have not yet seen proposals from Gladman for their development off Stonebridge Road
- There is a meeting with Rushcliffe Borough Council officers on 24.9.18 to reflect on the outcome of the Lantern Lane appeal/inquiry
- Meetings are being sought with Nottinghamshire County Council regarding (a) planning of primary school places and (b) Highways traffic access to new developments
- We are now in receipt of the Community Infrastructure Levy, CIL consultation letter from Rushcliffe Borough Council. It has been circulated to all Councillors with a deadline to reply by 26<sup>th</sup> October. This will be on the agenda for a future Planning Committee meeting

The Clerk read out 2 letters of objection to the proposed quarry extension and a report from Rempstone Parish Council.

The meeting was closed at 7:13pm

A number of concerns were raised and additional information and explanations given. Notts Wildlife Trust were appointed to advise on landscaping the current extraction site, and this should all be completed before any new extension is opened, provisionally scheduled for 2026-2030. Full detailed planning applications would be needed in advance and include what industrial plant is to be used and conditions such as working hours.

Details of the objections had been recorded and the Chair agreed to draft and circulate a response to be submitted from East Leake Parish Council to NCC
