- 1. The Local Plan Part 2 Hearing is underway to which the Parish Council has been invited to participate. This morning's session was 'Procedural and Legal Requirements. The afternoon session was about the trajectory for delivering housing, and developers' representatives were disagreeing with Rushcliffe Borough Council's figures as being over optimistic. Richard Mapletoft was asked to prepare a revised trajectory for the strategic sites.
- 2. The application for the National part of Stanford Hall has been approved as a delegated decision by officers and has gone through along with the access onto the A6006 which we are campaigning about. We had a meeting with Rempstone and Stanford Parish Council and a joint Press Release was agreed. The petition has over 800 signatures and was handed in today at County Hall and will be presented to Nottinghamshire County Council at their meeting on the 13th December. (The petition remains open and we could send them further signatures as an addendum.) A letter has been sent to our local MP and we have booked to see him in his Surgery on the 8th December. A meeting is also to be arranged with ARUP the developers. Richard Jenks has agreed to a sign going up in the fields adjacent to the A6006.

Stanford Hall A6006 Campaign – The petition is being presented to Nottinghamshire County Council on the 13th December. Further signatories to be delivered. The Chair and Clerk visited the Rt Hon Kenneth Clark, MP who had been helpful and agreed to get on board to improve road safety.

Rushcliffe Local Plan Part 2– The plan proposes no more housing in East Leake which we have supported. There are hearings daily for 3 weeks currently. A report from the inspector is anticipated at the end of January 2019 and could accept Rushcliffe's proposal for developments elsewhere than East Leake if the figures for a 5 year land supply are accepted.

Following discussion it was proposed by Cllr Marie Males and seconded by Cllr Kevin Shaw that we keep the option open to meet once the planning application has been submitted.

It was agreed that a public meeting would be held in due course for the Council to form a view on the application. This would be publicised to the public including letters to Stonebridge Drive and roads off.
