#### 18/PC/097 CHAIR'S ANNOUNCEMENTS

- The Chair informed the meeting that she had sent a written question for consideration by Rushcliffe Borough Council Cabinet, however the meeting was cancelled and she had instead received a reply from Cllr Roger Upton (Rushcliffe Borough Council) which she read to the meeting. He asserts that Rushcliffe is doing their best to expedite the building of houses South of Clifton.
- 2. The Chair and Clerk had been to visit Rt Hon Ken Clark MP regarding the A6006 and received a letter back from him enclosing a letter from Nottinghamshire County Council. Although there is no obligation to change the approved plans Nottinghamshire County Council are still talking to the developer.
- 3. Local Plan Part 2. We have not yet heard from the Inspector and therefore we do not know if the proposals will be agreed nor the timing of their approval by Rushcliffe Borough Council Full Council and consequently what effect this will have on developments in East Leake. A letter to a resident from the Programme Officer indicates that it could be June 2019 before Rushcliffe Borough Council approve it assuming the Inspector approves it with modifications.

### 18/PC/099 MATTERS ARISING FROM PREVIOUSLY CONSIDERED APPLICATIONS

- Field End Close It was noted that over 220 objections had been made by the public, the County Council Highways response has now appeared on-line. It was also known that the Wild Life Trust had objected regarding ecology and protected species. The Chair has written to East Midlands Airport and the Scouts for their comments. East Leake Parish Council has queried site notices as being inadequate but Rushcliffe Borough Council are not re-posting so there will be no extension to the consultation period.
- 11-13 Gotham Road Comments have been made regarding the new barriers which are on the landlords own land not on the pavement.

The Clerk also mentioned that we are expecting proposals from Via regarding the Village Centre junction in March and this may include relevant information. It was agreed to contact the relevant officers at Rushcliffe Borough Council and Nottinghamshire County Council for advice on whether such an assessment would be heeded in future planning applications.
