- Land North of Rempstone Road David Wilson Homes have emailed following the informal meeting and the chair tabled a draft response to their points. Having highlighted some details and changed one text clause it was agreed to send on behalf of the Parish Council.
- It was further agreed to seek a meeting with planners about the current developments
- Stonebridge Drive, Gladman's application was now out for consultation and a public Parish Council meeting scheduled for 12 March with letters delivered to most affected residents. A residents group has been formed to take actions, including visiting the MP.
- Following the advert about ownership of the strip of land at the end of Stonebridge Drive, it
 was agreed that East Leake Parish Council should seek legal advice about situations where
 ownership of a ransom strip is unknown and the impact on proposed housing developments,
 so that the Parish Council might be clearer in future about the legal processes involved,
 nominally about 1 hour
- Field End Close nothing to report
- Local Plan Part 2 the inspector has stated that subject to main modifications, the Plan is likely to be capable of being found legally compliant and sound. RBC to prepare a

consolidated set of modifications with a further consultation period before the inspector makes a decision.

- CIL Hearings, 20th March it was agreed that Cllr Carys Thomas should represent East Leake Parish Council and speak in line with the comments made in our submission
- S106 a report was sent to RBC and reply received 19th February, circulated to all
 councillors. Various details were highlighted, including availability of about £100,000 for Play
 facilities. It was agreed that Cllrs Thomas and Oatey should liaise with the Clerk to compile a
 response. It was also agreed to consider informing other Local Councils of our experience
 and ask them to share theirs
