20/01886/FUL British Gypsum Ltd

Extension to the existing test centre, fire resistant laboratory and storage building, consequential relocation of car park and new security gatehouse and entrance barrier.

It was proposed by Cllr Taylor and seconded by Cllr Shaw, that NO OBJECTION be made and AGREED unanimously

20/01906/TPO 53 Leivers Close

Trees; T1 (Walnut) – a minimum of 15% taken off the overhanging lateral branches and height. Reduce the spread by 2 metres.

Tom Pettit, RBC, has advised this is believed to be just a normal reduction, and that a **maximum** of 15% reduction is desired and will be required, subject to him visiting to confirm details

With the assurance that this is a maximum, not minimum, it was proposed by Cllr Oatey and seconded by Cllr Taylor, that NO OBJECTION be made and AGREED unanimously

20/01898/FUL 3 Hotchley Bungalows, Bunny Lane

Erection of front and side extension including new facing brick and skin and vertical cladding. Raised rear terrace

Cllr Taylor had visited the location and spoken to a neighbour. Concerns were aired about the size of extension and reference to "Dog Room", and whether this was a commercial venture which would require a change of use application, as well as whether vehicles would be able to turn if the new gate was closed.

It was proposed by Cllr Taylor and seconded by Cllr Oatey, that NO OBJECTION be made and AGREED by 4 votes in favour and 2 abstentions, but that a comment should be made raising concern about the turning area and to query whether it is known not to be a commercial dog breeder

 Review of Neighbourhood Plan – given the national circumstances and reply we had received from Locality, the former and current chairs of ELPC Planning committee felt we should not proceed at present, so it was AGREED to defer a review

20/PC/037 PLANNING APPLICATIONS

20/01841/FUL 2 Mulberry Way Provision of single storey rear extension

It was noted there were no comments from neighbours, but concern was expressed about the surface water drainage proposal, whether this was going into the public sewer or a soakaway. It was therefore AGREED not to make a decision pending more information and to request an extension to the response date

20/01731/FUL Land South of Swallows Barn, Ash Lane, Costock Erection of storage shed with mezzanine

It was noted that Highways and Environmental Health had not objected, but Cllr Thomas, as a Borough Councillor, had objected due to the adverse effect on the ridgeline around the village, and this location being in open countryside, therefore contravening LPP2.

It was unclear to councillors whether the land in the application was garden or agricultural land, or what use the building would have.

It was proposed by Cllr Griggs, and seconded by Cllr Maggs to OBJECT to the proposal, and agreed by 5 votes for and 2 abstentions

20/PC/036 Greater Nottingham Strategic Plan – consultation response

A draft response had been circulated by the Chair, Cllr Donna Griggs, resulting in a number of points being raised about the Plan, which it was agreed should be added

- Much of the data regarding East Leake is out-of-date
- Inadequate references to heritage sites and listed buildings, including St Peters in the Rushes
- Stanford Hall Rehabilitation Estate is not mentioned including DMRC and DNRC
- Congestion at the Railway Bridge on Gotham Road needs to be referred to

The draft response of Borough Councillors had been circulated to councillors and Cllr Thomas was thanked for her effort and expertise.
