- The Chair, Cllr Donna Griggs, confirmed that she had copied the comments East Leake Parish Council (ELPC) had made on the Greater Nottingham Strategic Plan to the MP for Rushcliffe and had received an acknowledgement.
- Councillors were asked whether ELPC should respond to the consultation on proposed changes to the national planning system, and a special meeting of the Planning Committee, open to all Parish Councillors, is to be held on 29th September, ahead of the 1st October deadline.

 Confirmation had been received that investigations into the Tattoo Parlour are continuing.

20/PC/042 PLANNING APPLICATIONS

20/01841/FUL 2 Mulberry Way – Provision of single storey rear extension

The applicant had informed that the surface water will drain into a soakaway, subject to approval by Building Control. Concern was expressed that neighbouring properties should be protected from any risk of flooding.

No objection was proposed by Cllr Thomas, seconded by Cllr Griggs, and AGREED unanimously, as long as Building Control allay drainage concerns.

20/02088/FUL Swallows Barn, Ash Lane – Single storey rear extension (Resubmission)

Cllr Thomas informed the committee about the history of this proposal, changing in size, now increased back to original request. Impact on the countryside a concern, particularly from the large glazing of a gable at a great height, which would cause reflections from the setting sun.

It was proposed by Cllr Griggs, seconded by Cllr Taylor, to OBJECT, and AGREED by 6 votes for and 1 abstention.

20/PC/043 TO CONSIDER A RESPONSE TO THE EAST MIDLANDS REGENERATION PLANNING APPLICATION

20/01826/CTY on the Rushcliffe planning portal. Proposed development of the East Midlands Energy Re-Generation (EMERGE) Centre (a multifuel Energy Recovery Facility, recovering energy from waste material) and associated infrastructure. Rushcliffe are themselves consultees on this, but the application will be decided by Notts County Council. To make Rushcliffe aware of councillors' views, response to be made here.

<u>ES/4154</u> on the Notts County Council planning portal. <u>https://www.nottinghamshire.gov.uk/planning-and-environment/planning-applications/commenting-on-planning-applications</u> There was support for the need for a positive waste recycling strategy and clean energy re-generation in Rushcliffe and Nottinghamshire. ELPC would, however, encourage both Councils to be more forward thinking and consider other options to improve arrangements for recycling.

Concern was expressed about potential odour, noise and air pollution from the site impacting on the residents of East Leake and other villages. In addition, councillors were concerned about the potential impact on health, increased traffic on local roads, and how the waste product arising from incineration would be disposed of.

It was agreed to respond on both the Rushcliffe Borough Council and Notts County Council portals.

Cllr Thomas informed the meeting that Rushcliffe Borough Council Planning Committee had supported the application for a green energy generation plant at Ratcliffe on Soar Power Station site

20/PC/055 PLANNING APPLICATIONS

20/01974/FUL 48 Main Street – Demolition of existing rear garage outbuilding and erection of new dwelling and detached garage

Councillors noted a number of adverse comments on the planning portal from consultees and nearby residents, including that the history of one outbuilding should be recorded, and that trees on boundary should not be removed. There will be an increase in traffic on and off Main Street very close to the main T-junction in the village centre.

It was pointed out that the application was in breach of policy V1 of the Neighbourhood plan that new buildings in the Conservation area need to be justified as necessary, which a house may not be

It was proposed by Cllr Griggs, seconded by Cllr Maggs that we OBJECT and agreed unanimously

20/02198/FUL 5 Bateman Road – Construction of new front porch. Alterations to windows and doors on all elevations. External render to front elevation replacing artificial stone.

It was proposed by Cllr Griggs, seconded by Cllr Mulligan that we do NOT OBJECT and agreed unanimously

20/02300/REM Land North of Rempstone Road

Application for approval of access, appearance, landscaping, layout and scale of outline permission 16/01881/OUT for the erection of 235 dwellings. Rushcliffe Borough Council have admitted confusion about applications for this site, and provided new clarification in a new consultation, with a later deadline

Consideration was therefore DEFERRED until 27th October

20/PC/056 TO RESPOND TO CONSULTATION ON NEW ZEBRA CROSSING ON GOTHAM ROAD

TP2050119 – Gotham Road Zebra. RU0403

The drawing for a new zebra crossing on the existing road humps was discussed, with proposed wider pavement and central reservation, barriers and beacons, but not traffic lights. The northbound bus stop and clearway will also be relocated nearer the junction

Concern was expressed that 2 lanes of traffic merge into one over the crossing, and that this opportunity should be taken to widen the end of the central reservation at the T-junction to allow pedestrians with pushchairs to wait more safely – people will still cross here despite the new zebra 50 yards/metres away

It was proposed by Cllr Taylor and seconded Cllr Mulligan that NO OBJECTION be made, with 6 votes in favour and 1 abstention

TP2050119 – Gotham Road parking restrictions
The proposal for double yellow lines either side of the car park entrance was disappointing not to extend to the entrance, and concern was expressed about enforcement action being required, especially soon after installation.

It was proposed by Cllr Mulligan and seconded Cllr Griggs that NO OBJECTION be made, and AGREED unanimously

Comments from the Conservation Officer were noted, and that a neighbour was already overlooked. The proposal would be further forward and not match the older existing house, and be an "ugly" addition

Cllr Taylor proposed OBJECT, seconded by Cllr Thomas, and AGREED unanimously

20/02103/FUL 2 Brookside — Partial change of use to convert back room of barbershop into tattoo parlour

Objections from 1 neighbour were noted, and some questions asked about accuracy of drawings.

NO OBJECTION was proposed by Cllr Maggs, seconded by Cllr Mulligan, and AGREED unanimously, but with comments raising concern about parking on-street, and security of any sharps waste

20/02413/FUL 20 Twentylands Drive – Erection of an attached garage and erection of boundary wall and gate (Resubmission)

Neighbours comments about the long high, 2 metre wall and reduced visibility for traffic were noted.

Cllr Taylor proposed OBJECT, seconded by Cllr Mulligan, and AGREED unanimously by 6 votes in favour and 1 abstention, as the proposal was not in keeping with the currently open plan residential area
